PLAN WHEN YOU APPLY FOR YOUR PERMIT.

A COPY OF THE MACOMB TOWNSHIP FENCE ORDINANCE IS AVAILABLE UPON REQUEST IN OUR OFFICE.

PROCEDURE

1. MAKE APPLICATION / COPY OF DRIVER'S LICENSE.
2. WE WILL ARRANGE A GRADE CHECK WHICH WILL TAKE APPROXIMATELY 2-3 DAYS. (THE GRADE CHECK INVOLVES THE WATER DEPARTMENT GOING TO THE LOCATION AND MAKING SURE NOTHING IS CONSTRUCTED IN THE EASEMENTS AND THAT NO ALTERATION OF THE GRADE HAS BEEN MADE.)
3. WHEN GRADE CHECK HAS BEEN COMPLETED AND APPROVED, WE WILL TYPE THE PERMIT AND NOTIFY THE APPLICANT TO COME IN TO SIGN, PAY FOR AND PICK UP THE FENCE PERMIT (IT TAKES 7-10 WORKING DAYS TO GET A PERMIT.)
4. THE PERMIT HOLDER MUST CALL IN FOR A POST HOLE INSPECTION AND THEN A FINAL INSPECTION ON THE FENCE.

NOTE:

MACOMB TOWNSHIP HAS NO JURISDICTION OVER SUBDIVISION RESTRICTIONS, THEREFORE, IF ORDINANCE REQUIREMENTS ARE MET, A PERMIT WILL BE ISSUED.

PLEASE CHECK YOUR SUBDIVISION RESTRICTIONS CAREFULLY, AS SOME DO NOT PERMIT FENCING!!

NO DOUBLE FENCING OR SHARP/POINTED EDGES ALLOWED. PERMIT HOLDER IS RESPONSIBLE FOR IDENTIFYING ALL PROPERTY LINES BY EXPOSING ALL LOT PINS. PERMIT HOLDER IS RESPONSIBLE FOR OBTAINING ANY REQUIRED UTILITY EASEMENT ENCROACHMENT APPROVALS.
